**PRESENT:** Cllrs. H Martin, M Galvin, M Thomson, M Ahir and the Clerk A Costigan.

No member of the public was present.

**Fifteen minute rule** – comments from members of the public. None raised.

**3988 COUNCILLORS:** Recruitment attempts are continuing.

**3989 APOLOGIES FOR ABSENCE:** Apologies were received from Cllr A Bostan, M Welthy and S Helliwell. The apologies and the reasons for absence were accepted.

**3991 MINUTES OF THE LAST MEETING:** The minutes of the Village Council meeting held on 2 June 2021 were **approved**.

**MATTERS ARISING:** Cleaner Streets Fund. All litter picking equipment purchased from the grant has now arrived.

**Climate Action Fund bid.** The grant awarded may not be sufficient and individual villages may be asked to contribute.

**Parking on Hallowes Park Rd.** The headmistress of Parkside School has sent a reminder to parents asking them not to keep the car engines running while they wait.

**Planning Protocol Working Group.** Cllr Thomson attended the first meeting of the Group.

**Parking buddies.** Parkside School will purchase the parking buddies for which a grant was received from the Village Council and site them in permitted locations. **Old Village Hall Tree** The tree has been added to the waiting list for removal. **Village Hall Showcase** Postponed until 4 September as the lifting of Covid restrictions was delayed.

**Former Station Yard planning application.** The expiry date is now 31 August 2021.

## **Applications to consider:**

**Application 21/03077/FUL** Hunter Hill Farm Hill End Lane Harden Amendments to existing approved dog kennel approved under application 20/00220/FUL

The following amendments have been made since the approved drawings.

The building is mirrored to provide shelter to the animals from the prevailing wind.

The building is increased slightly from 11.6m to 12m and from 5.85m to 6.65m.

The external wall materials are changed from timber cladding to natural stone.

The roof removed from the open kennels.

Roof material changed from metal profile sheets to slates

Cullingworth Village Council main concern is that the development does not result in the external dimensions of the building extend beyond the external dimensions of any existing building at any given point. The materials are in keeping with the local surroundings. The openness of the Green Belt should therefore, remain unaltered.
